The fee for the Segment I course at Mosley's Driving and Testing Center is **350.00**. This class will start the **6<sup>th</sup> day of March** in the year **2017**. Classes will be held at 1865 Henry St. Muskegon, MI. Class time: Mon. - Thurs. **5:15 P.M. -7:15 P.M.** Driving time is in addition to this.

The above fee for this course will entitle the student to a quality driver education program, which will include the following:

1. Twenty four (24) hours of classroom instruction.
2. Six (6) hours of behind-the-wheel driving instruction. Mosley's Driving & Testing Center will conduct the behind the wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program.
3. Proportionate share of expense for use of Mosley's automobile, gas, oil, maintenance insurance and minor repairs.
4. Proportionate share of space, administration, clerical, and instructional costs.
5. The student will use a copy of What Every Driver Must Know and How To Drive at no extra charge.
6. You must score at least 80% on the final exam to pass this class. You may retake the exam if you do not score 80%.
7. Any classes missed must be made up in the next session. You will be given the date of the corresponding class you will need to attend.

You must be at least 14 years and 8 months by the first day of class. The school reserves the right to limit class size and to cancel classes with insufficient registration. **Class fees are refunded ONLY when the class is canceled, upon receipt of a physician's statement of illness, or if the enrollee moves out of the area prior to the start of class.** You **MUST** return a signed contract with a **\$100.00** deposit prior to the start of the class in order to ensure a place in the class. The first 36 students paying their deposit will be admitted to class. The remaining balance of \$250.00 is due on the first day of class or you will not be admitted to class and the deposit will be forfeited. Cash or check only accepted. A \$50.00 processing fee will be applied if you change the date of class less than 14 days prior to the start of class. A student needing additional driving instruction at the conclusion of class will be offered private lessons at the rate of \$35.00 per hour. Replacement certificates are available for \$10.00
