For a student to participate in segment 2, verification must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.

**You must bring your Level 1 license and proof of 30 hours (minimum) of logged driving time with you the first night of class. Also please bring a pen or pencil**

The school reserves the right to limit class size and to cancel classes with insufficient registration. Class fees are refunded only when the class is canceled, upon receipt of a physician's statement of illness, or if the enrollee moves out of the area prior to the start of class. A \$20.00 processing fee will be applied if you reschedule the class to another date less than 7 days prior to the first day of class. You **MUST** return a signed contract with the complete nonrefundable **\$70.00** payment **PRIOR** to the first day of the class in order to ensure a place in the class. **Class is filled on a first come, first serve basis.**
